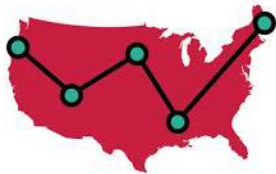

## The Status of Women in Nebraska, 2015: Highlights

Women in Nebraska have made considerable advances in recent years but still face inequities that often prevent them from reaching their full potential. Since the 2004 *Status of Women in the States* report was published, a higher percentage of women have bachelor's degrees, and women are more likely to work in managerial or professional occupations. Yet, the gender wage gap in Nebraska has widened and, as in all other states, women in Nebraska are less likely than men to be in the labor force and more likely to live in poverty. Women also continue to be underrepresented in the state legislature.



If current trends continue, women in Nebraska will not see equal pay until the year **2066**.\*



Women hold **20.4%** of seats in the state legislature.

### Key Findings

- Nebraska's best grade is in the area of health and well-being, for which it receives a B. Its worst grade is in reproductive rights, for which it gets an F.
- Nebraska women who work full-time, year-round earn 73 cents on the dollar compared with similarly employed men.
- Approximately 25.9 percent of those working in science, technology, engineering, and mathematics (STEM) fields in Nebraska are women, compared with 28.8 percent nationwide.
- As of 2015, there are no women of color in statewide elective executive office in Nebraska, and no women of color from the state in the U.S. Congress.
- Women in Nebraska who are unionized earn \$227 more per week, on average, than those who are not represented by a union.
- Approximately 30.7 percent of women in Nebraska have a bachelor's degree or higher, an increase of about 8 percentage points since 2000.
- In 2012–2013, 34.6 percent of Nebraska's four-year-olds were enrolled in state pre-K, preschool special education, or state and federal Head Start.
- Heart disease is the biggest killer of women in the United States. Nebraska ranks 16 of 51 with a mortality rate of 117.1 per 100,000.
